On-line applications are invited from the students belonging to below mentioned categories pursuing studies within or Outside the UT of Jammu & Kashmir (within India) in Government/Government Recognized Educational Institutions undergoing XI, XII, Diploma, Graduation/Post-Graduation Level Courses, B.Ed, M.Phil, Ph.D & Professional/Technical Degree Courses at Under Graduate or Post-Graduate Levels etc. On-line registration will be done through State Portal under **URL:- <https://jk.gov.in/jkeservices>**. Only online applications under these Schemes will be accepted and no request for Offline applications will be entertained:-

1. **Other Backward Classes, (OBCs)**
2. **Economically Backward Classes, (EBCs)**
3. **Physically Challenged Students, (PCPs)**
4. **Denotified Nomadic & Semi Nomadic Tribes, (DNTs)**

INSTRUCTIONS FOR AVAILING THE SCHOLARSHIP SERVICE:-

1. **To avail the Scholarship service a candidate has to log in URL:- <https://jk.gov.in/jkeservices> and before applying in the Service, User has to register using the Register Link given on the menu.**
2. **Applicant has to upload the scanned photo (jpg image) of size less than 20 kb before registration.**
3. Please note the user ID and Password entered by the student during the registration for subsequent login & uploading of details.
4. Please select the role type as Citizen while entering login credentials by the Applicant.
5. Please note the Citizen ID after successful registration as it will be required at the time of availing the service.
6. After login, Applicant has to click on the e-services tab in the left menu and thereafter click on the social welfare and under social welfare click on Post-matric Scholarship.

The value of scholarship includes maintenance allowance plus non-refundable fee compulsorily payable by the student, studying in Government or Government recognized educational Institutions by the Government/UGC/Board of Technical Education and similar Statutory Professional Councils of India for recognized, courses.

The following documents in original shall be uploaded & xerox of the same should be attached with the hard copy of downloaded Scholarship application form except "Income Certificate/Fee Receipt/Bonafide certificate & Affidavit" which should be attached in original:-

01. One passport size photograph.
02. Permanent Residence Certificate (State Subject Certificate/Domicile Certificate).
03. Fee Receipt & Original Bonafide certificate showing current fee structure and class/course.
04. Duly attested Promotion Certificate, in case student has passed previous examination.
05. In case of Hosteller a Valid Hotelier Certificate issued by the warden of the Hostel.
06. Income Certificate.
 - Parents /Guardians current income certificate, in original from the concerned **Tehsildar** (in case of students whose **parents/guardians** are **not Government employees**). In case of wards of **Government employees, salary certificate** issued by the concerned **Drawing and Disbursing Officers**. (*Income certificate with cutting/mutation will lead to rejection of Application forms.*)
07. Valid Category Certificate in case of **OBCs and DNTs** from the competent authorities.
08. For **Economically Backward Classes, EBCs** only those students who do not belong to any Category can apply.
09. Disability Certificate- (indicating **40% & above disability**) in case of Physically Challenged students (PCP).
10. **Aadhaar Number alongwith xerox of Aadhaar Card and seeding of Aadhaar with bank account will lead to smooth transaction of sanctioned amount of scholarship in favour of eligible students.**
11. **Mobile Number is Mandatory.**
12. **Affidavit to be submitted/enclosed with hard copy by the student for which the specimen of Affidavit is as under:-**

THE GRANT OF SCHOLARSHIP IS SUBJECT TO THE FOLLOWING:-

- I. Mere filling of on-line scholarship application form will confer no right on the student that he/ she will be granted scholarship.
- II. Preference will be given to the Government Institutions.
- III. Scholarship will be restricted to availability of funds and also the merit and income.
- IV. The income limit prescribed for various categories is as under:-

- **Other Backward Classes, OBCs, Rs.2,50,000/p.annum**
- **Economically Backward Classes, EBCs & Physically Challenged, PCP:- Rs. 2,50,000/p.annum**
- **Denotified Nomadic & Semi Nomadic Tribes, DNTs: - Rs/- 2,50,000/p.annum**

- IV. A scholarship holder under these Schemes will not avail any other scholarship/stipend for pursuing the same course/class from any other Agency/Department.

The applicants are advised to take print-out of the duly filled-in application form, after submitting it on-line and submit the same to the concerned Institution/College/University alongwith all requisite documents. The concerned Head of Institution/College/University will verify the on-line applications with hard copies and forward the hard copies to the concerned Domicile District Social Welfare Office for further scrutiny/verification and for record and reference. **Further no extension beyond 30th June 2021 will be given to students for submission of online application form.**
