#### Action Taken:

- Rescheduled the academic calendar to include buffer weeks for revision and reinforcement.
- Introduced monthly syllabus progress reviews to track completion and address delays.
- Organized remedial and extra classes for students in need of additional support.

### Skill-Oriented Curriculum

Feedback: Limited emphasis on soft skills, employability skills, and practical learning.

#### Action Taken:

- Integrated soft skills and employability modules into the curriculum, focusing on communication, teamwork, and problem-solving.
- Collaborated with industry experts for skill-development workshops and guest lectures.
